2. Eligibility criteria for admission

- {a} Education Qualification: Minimum pass class 10th with 40% overall marks and 40% MARKS IN ENGLISH. MATHEMATICS AND SCIENCE SHOULD BE MAIN SUBJECT IN CLASS 10TH. In case has less than 40% in English, should have the same in class 12th. Candidates must able to read write, speak and understand English.
- **(b)** Age: Not before: 01.01.98 Not after: 01.07.2005
- {c}Medical Standard: Both eyes 6/6 with no aids, no colour vision, no colour blindness. No stemming, handicapped etc. is permitted. No deformity in body and medical fitness certificate {fit for sea service} by a DG Shipping approved doctor.
- 3. Process of registration: person applying for the course to check eligibility criteria at his own and reach institute along with original and set of photocopy of academic documents{Duly self-attested} for submission. Computer based Test shall be conducted by the counselor to select/reject your candidateship for course.
- 4. Syllabus for Computer based Test: {CBT}: You will be attempting institute tailored online test in institute {Note that the test is implemented by the institute with a sole purpose of selecting good and competent candidates for our institute only for GP Course}. This test will be covering the following aspect:
 - (a) Duration of Computer based Test: 30 minutes

- {b} Question based of standard 10th in English, Mathematics, and Science {technology}- 40% marks of total CBT Marks.
- {c} Question of standard 12th in Physics, chemistry mathematics, Physical education, -15% Marks.
- {c} General knowledge and current affairs: only on politics, sports, current events. 10% marks of total marks.
- {d} General reasoning: 10% marks of total test marks.
- 5. Interview/oral test: Interaction verbal conversion with student on family, person, habits, hobbies, course information, nature of training, sea service awareness and Seafaring as a career. 20 marks
- 6.. Qualifying marks:
- {a} Computer based CET :30%
- {b} Interview: 20%
- 7. Process of attending Computer based test: Student applying for admission in course shall be briefed by the counselor on course, type of training, eligibility criteria and seafaring as a career, course fees and process of submission of course fees. O receiving /submission written confirmation to attend the CBT from the candidate, shall the test will be conducted.
- 8. CBT Fees: The institute shall charge a nominal fees for Computer based Test of INR 500/ {Rupees five hundred only} this will not be forming/ extra than course fees and non-refundable once logged in for CBT.
- 9. Seat booking/ registration fees: On obtaining/scoring marks as per above {Para 7} apply for registration. Eligible candidate to submit an initial amount is INR 50,000/ {Rupees fifty thousand only) in the counter in institute through bank transfer, UPI or NEFT. Registration fees is fully refundable to a candidate if becomes medically unfit prior to commencement of course only.
 - $\{a\}$ Admission fees: INR 1,45,0000/ {One lac thirty thousand only} -between 20.12.2022 to 25.12.2022
 - {b} INR 50,000/ {Fifty thousand) Third Installment on 05.04.2023.
 - {c} **Security Deposit**: Students admitted in course shall have to deposit INR 5,000/ {Rupees five thousand only} as Security depot.it shall be charged off against laundry sports, library games and All India Exit Exam fees for All India Exit Examination conducted by the BES}.

Note; Course fee covers food, accommodation, uniform, books, stationary, ship visit, INDoS No, Indian CDC, Basic Safety training course including STSDSD.

- 12. Counselling and documentation to course participants: Institute shall conduct counseling of all selected candidates in course from 16th to 20th December 2023. During the original academic documents/ certificates shall be verified by the institute and kept in office as to produced them in any schedule/unscheduled/ surprise/ISO and Comprehensive inspection by the DGS or its allied officers. In addition to above, submission of passport is compulsory by 31.12.2022 by the selected students in the office of this institute or the admission shall be carried forward in next bath. Waited list students shall replace your seat.
