



Pre Sea Course Diploma in Nautical Science {DNS}Ldg to BSc Applied Nautical Science.

Course Intake - 40 students

Course scheduled from - 01.08. 2022.

Duration of course : First 02 semester at institute campus, 03 semester on board

Eligibility criteria for admission:

Pass class 10+2 or its equaling from a recognized board by the Central Govt. of India or state Govt./NIOS with 50% marks in English.

- Have minimum 50% marks in English in class 10th or 12th and 60% in aggregate of Physics, Chemistry and Maths aggregate in class 12 (10+2)

(c) BSc Students have 50% in BSc course and Physics be one of the subject in any year.

(d) Relaxation in marks PCM; 05% relaxation to the students falls under SC/ST category. The certificate shall be required at the time of counseling.

Age limit: Minimum 17 years and maximum 25 years as on the date course commences (Age relaxation as per existing rules of Govt. of India)

Medical standard : Both eyes 6/6 with no aids and no colour blindness, no deformity in body, no stemming, No any kind of handicapped is accepted in course. Fit for sea service,

Requirement of passport: the original passport is to be submitted in institute office with in 10 days of commencement of course. No INDoS application can be processed hence such students can not be uploaded in Batch details data .

Adhaar card : students to submit coloured scan copy of their Adhaar card for admission.

Course fees: {a} IMU Counseling and Programme fees : INR 35,000 {To be paid on passing Online IMU CET only}

(a) First Semester Fees: 1,55,000/- (To be paid on commencement/ entry in Institute

(b) Second semester fees : 1,55,000/ 2nd semester

(c) Procedure for registration in institute; This is important to note that the admission of student shall be processed on obtaining a rank in All India Common Entrance test conducted by the Indian Maritime University Chennai in this course. This test {CET} shall be on 29.05.2022 in across major city in India.

Students aspiring admission in this institute can register themselves for the course from 17.03.2022 to 30.04.2022 by paying INR 20,000/ {Twenty thousand } only as part of


