In case has less than 40% in English or oval all %, should have the same in class 12th. Applicant should able to read write, speak and understand English.

Age: Date of birth Not before - 02.01.2001 Not after - 02.07.2008

Medical Standard: Both eyes 6/6 with no aids, no colour vision, no colour blindness.

No stemming, handicapped etc. is permitted. No deformity in body and medical fitness certificate {fit for sea service} by a DG Shipping approved doctor.
